

***Biotechnology Bulletin* Copyright Transfer Agreement**

Article title:

1. All the authors agree to transfer all the copyrights of the article (main body text and all related attachments) to the Editorial Office of *Biotechnology Bulletin*, including but not limited to the right of reproduction, distribution, information network dissemination, broadcasting, performance, translation, compilation, adaptation. Including:(1) The right to publish or use the Article via various media or in all languages. (2) Without prejudice to the author's rights and interests, using the Article in a manner that does not violate the current or future laws and regulations of the People's Republic of China. (3) Licensing all or part of the above rights to a third party.

Biotechnology Bulletin is an open access journal. All articles will be immediately and permanently free on the official website (<https://biotech.aiijournal.com/>), allowing anyone to read and download as long as published. Permitted third-party reuse of the article is defined by the following user license: Creative Commons Attribution-NonCommercial-NoDerivatives (CC BY-NC-ND 4.0). Authors have the right to use the article under the following circumstances: reproducing, disseminating, and using the article freely in accordance with the CC BY-NC-ND 4.0 License, such as non-commercial academic seminars, communication, academic reports, and lectures.

Articles may sometimes be accepted for publication but later rejected in the publication process, even in some cases after public posting in “Articles in Press” form, in which case all rights will revert to the author.
